BOARD OF SAFETY MEETING

August 8, 2024

The Board of Safety Meeting was called to order by Chairman Eric Graf at 5:32 p.m., in the Schererville Police Department Meeting and Training Facility, 25 E. Joliet Street, Schererville, IN.

Attendance was taken with the following Board Members present: Eric Graf, George Kouros, David Jaroszewski, and Giovanni Veitkus. Absent: David Eenigenburg, Deputy Fire Chief David Meyer and Recording Secretary Stephanie Bottiger.

ITEM A. FD – Approval to Hire Part-Time Employees

Chief Patterson requested approval from the Board to hire two part-time employees to fill open slots:

- Michael Van Waardenburg Firefighter/EMT
- James Miller Firefighter/Paramedic

Motion made by Mr. Kouros, seconded by Mr. Jaroszewski. Motion carries (4 - 0). It should be noted there was a third name on the list to hire, Anthony Jackson, Chief Patterson stated his name was withdrawn.

ITEM B. PD – Time Promotion for Officer Madeline Guillermo

Chief Sormaz requested approval from the Board for the time promotion for Officer Madeline Guillermo, badge #226, from Probationary Patrolman to $1^{\rm st}$ Class Patrolman, effective August 22, 2024. Chief Sormaz advised the Board she had completed all necessary requirements for all the stages of time promotion, according to Police Policy and Procedure. As motion was being made by Mr. Jaroszewski, Chief Sormaz corrected the effective date from August 22, 2024 to August 19, 2024. Motion made by Mr. Jaroszewski, seconded by Mr. Veitkus. THEREUPON, Reports

ITEM A. Police Chief

Chief Sormaz thanked the residents, visitors, vendors, and all the first responders for attending the annual National Night Out that took place on August 6, 2024, at Redar Park.

For the month of June, 2024, the Patrol Division responded to 1,858 incidents and took 98 accident reports. There were 197 total arrests. The Patrol Division filed 277 charges of which 98 were Class A Misdemeanors, 50 were Class B Misdemeanors, 91 were Class C Misdemeanors, 2 were Level 4 Felonies, 3 were Level 5 Felonies and 33 were Level 6 Felonies. The Patrol Division served 95 total warrants. They performed 643 traffic stops resulting in 420 citations issued of which 92 were local ordinances and 328 were state infractions. 448 warnings were also issued. The Patrol Division performed 189 vehicle searches, of which 58 were K9 vehicle searches. There were 161 Proactive Patrols.

For the month of June, 2024, the Criminal Investigations Division (CID) filed 43 criminal charges which were the result of 22 cases. Of these 43 charges, 24 were felony, and 19 were misdemeanor. 10 were filed in the Schererville Town Court, 30 were filed in Lake County Court, and 3 were filed in the Lake County Juvenile Court. The CID investigated 64 incidents for the month of June.

For the month of July, 2024, Schererville Police Officers attended 175 hours of training.

For the month of July, 2024, the Animal Control Report was unavailable.

ITEM B. Fire Chief

For the month of July, 2024, the Schererville Fire Department performed 30 inspections, responded to 369 incidents of which 271 were EMS related, 65 were Fire related, 29 were Alarms/Investigations, and 4 were Fire Prevention, Inspection and/or training. They also attended 392.3 hours of training.

Ms. Glauas stated there would be a Logan's Love Golf Outing on September 28, 2024, at Wicker Park, in Highland, from which the proceeds would benefit the sensory events they hold throughout the year. Mr. Kouros asked if Councilwoman Arvanitis had a hand in obtaining the Ben's Blue Bags for the Officers' squad cars, to which she replied yes.
