THEREUPON, Reports

Moment of Silence for Larry Tucker who recently passed away. He was an ex-Town Council Member and currently represented the Town as a member of the South Shore Convention and Visitors Authority.

Fire Chief Patterson stated that the Fire Department responded to $273\ \text{EMS}$ related calls, $64\ \text{Fire}$ related calls for a total of 337 calls for the month of May.

Mr. Novacich stated that tonight kicks off the five day Celebrate Fest, and he thanked all of the departments who are assisting with that.

ITEM A. Consider Conveyance of Warranty Deed from the Estates at Bristol Farms Homeowner Association, Inc. to the Town Of Schererville (Outlots "A" and "B") (Deferred from May 11, 2022 Meeting)

Mr. Volkmann stated that in Bristol Farms, there are two parcels of property that the HOA owned originally, one is basically a detention area and the second one was plotted as park land. He stated that it is in an area that is under served by any kind of a Tot Lot Park. He stated he doesn't know if the Park Department would entertain it for any type of future development. He stated that it is an area that is only served by Stephen's Park and Smith Park. He stated that the HOA has been trying to disband, one of the things that was a stumbling block for them over the years was that they owned this property, which created a liability as a group. He stated that the President of the HOA has offered it to the Town, so they no longer have to pay taxes on it.

Mr. Guetzloff made a motion to approve the Conveyance of Warranty Deed from Estates of Bristol Farms HOA to the Town of Schererville, seconded by Mr. Connelly.

Mr. Johnson asked Mr. Novacich if there is any need for a park at this location. Mr. Novacich stated that they have Lake of the Meadows Park on Hilbrich Drive, which is probably less than a half of a mile from there. Mr. Johnson asked Mr. Volkmann if we accept these properties are we going to have to mow them, is it a cost and expense to us now. Mr. Volkmann stated that parcel A, the detention area, no one does anything to that, and we have never mowed that. Mr. Volkmann stated that the other parcel is mostly natural, he said there could be a mowing liability at that area. Mr. Johnson asked Mr. Volkmann if this HOA owns any other outlot parcels that they have to maintain. Mr. Volkmann advised him no.

Mr. Guetzloff stated that the main reason he is voting to accept it is because he hopes somewhere in the near future we can put a little park in there.
