## **BUILDING & PLANNING DEPARTMENT**

## **PET LICENSES**

Ordinance #1549 requires that all dogs and cats are to be licensed each year by the 31<sup>st</sup> of March to avoid late fees. Please take current shot record and proof of spaying/neutering to the Schererville Police Department. (No more than five (5) dogs and/or cats combined over the age of three months may be kept on any residential, commercial or other premises within the town unless the owners of the animals hold a valid permit.) Dog – **not** spayed/neutered \$20.00.

Cats - **not** spayed/neutered \$10.00. Dogs/cats that are spayed/neutered are only \$5.00. Failure to obtain a license within the time period specified will result in a \$10.00 late fee as well.

## **CLERK-TREASURER'S OFFICE/UTILITY BILLING**

The Utility Billing Department is located within the Clerk-Treasurer's Office. Utility bills include charges for water, sewer, hydrant, and trash collection. All utility bills are due by the 24<sup>th</sup> of every month. Payment can be made directly at the office during normal business hours, by mail, or left in one of 2 drop boxes. Boxes are located both in front of and behind the Town Hall. For your convenience, there is an Auto-Withdrawal Payment Plan available at no additional charge – See additional sheet attached for directions on how to sign up. Visa/MasterCard/Discover credit cards are also accepted with a fee. The stub with your name and address must accompany your payment.

**Cash payment should never be left in a drop box.**

## **VOTER REGISTRATION**

You can apply at the Clerk-Treasurer's office. You may ask for a mail-in application, absentee ballot or you may complete the application and return it to county. ### **APPLICATION FOR SERVICE**

Customers applying for service are required to sign an Application for Service form at the Clerk Treasurer's Office and present a government issued ID. Application for service should be completed at least three days prior to needing service at a location. This practice also applies to existing customers moving to new locations within the Town of Schererville.

### **SUMMER SEWAGE RATE**

October through April bills will reflect normal charges for sewer use. Summer brings the watering of lawns, washing of cars, and filling of swimming pools. With this water usage in mind, your water bill will reflect **discounted sewer rates for the water used from May through August.** (July, August, September and October bills).

## **TRASH AND RECYCLE**

Please have garbage & recycling bins out by 6:00AM. Pick up for residents north of RT 30 is Wednesday and south of RT 30 is Thursday. Recycling is every other week. Please see the attached sheet for the schedule. One large item per week (furniture, etc.) will be picked up. Items containing C.F.C.'s (refrigerators, freezers, dehumidifiers, etc) will not be picked up. Electronics are not an acceptable trash item. Pick up will be one day late for those weeks with the holidays of **New Years Day, Memorial Day, 4<sup>th</sup> of July, Labor Day, Thanksgiving and Christmas.** If you have any questions about recycling or the service that you are receiving from our waste hauler please call Republic Services at (219) 926-1046

## Town of Schererville Utilities Auto-Withdrawal

Work lots of hours? Busy with the kids? Out of town often?

- Here's what you need to know:

- ✚ No worries of forgetting to pay the water bill
- ✚ No Late Fees
  - \* Payment is withdrawn automatically on due date from your specified checking account (24<sup>th</sup> of every month)
- ✚ Hassle Free – No more writing checks – No need to call and make a payment on the phone – No stamps needed – No running to Town Hall to make a payment!
- ✚ You will receive your water bill as usual so you know what the monthly charges are or opt to go PAPERLESS. It will be marked with the following: **DIRECT WITHDRAWAL – DO NOT SEND PAYMENT**
- ✚ Safe and secure – Your bank information is securely maintained
- ✚ **Sign up now for Auto-Withdrawal by completing the application below, attaching a cancelled or voided check from your selected bank account and returning it to: Town of Schererville Utilities, 10 E. Joliet Street, Schererville, IN 46375**

### Provisions for Auto-Withdrawal

- **Availability of Funds:** You are responsible for having enough money in the indicated account on the payment date. You will be charged the same as if a paper check “bounced” should your payment be returned with insufficient funds (\$20.00). In addition, your Auto-Withdrawal service may be cancelled if two payments are returned in a 12-month period.
- **Termination:** This authorization will remain in effect until we receive written notice from you 30 days before the cancellation date or until your utility service has been terminated.
- **Bank Account/Address Change:** You are required to notify us of any account or address changes to ensure timely payments. You are responsible for submitting a new application when a bank account or address change occurs.

Second Monday in January – April 15	Period during which permits for requests by Schererville residents, groups, businesses, or organization, only shall be issued, on a first-come first-serve basis.
April 16	First-com first-serve basis for permits, regardless of residence.

All appropriate rental fees and deposits must be paid in full at the time of reservation. Residents representing non-Schererville groups, businesses, or organizations must pay the non-resident rate and adhere to the above timetable.
